## Minutes from Texas State Convention Committee Meeting Broadway Group, Fort Worth, July 28, 2007

## Reports:

Notestaker read notes taken from the Committee meeting held on June 16<sup>th</sup> at the Towneast Group. Both Facilitator and Treasurer attended the Texas State Convention Advisory Board in Austin, TX on June 30<sup>th</sup>. Awakenings and Carrying The Message will have a fundraiser on Saturday, October 6<sup>th</sup>. More details will be revealed.

Co-Facilitator Report was verbal. Attended Awakenings Activities Meeting and was impressed with the enthusiasm of planning the fundraiser.

Hotel Chair reported contact information has been exchanged with sales manager at the Crown Plaza. He will receive a copy of the contract within the next week. He will set up a meeting in the future to start going over the set up requirements.

## New Business:

In order to attract committee chairs, at fundraisers, we want to expand and explain responsibilities. <a href="www.tscna.org">www.tscna.org</a> shows open positions for this convention committee. Plans include visiting the Fort Worth ASC, go on "outreach" visits to other groups. We want to make sure we keep in mind that God is in charge.
